# **BRETT DIXON**APIL Secretary, Brett Dixon Training

Brett is a consultant solicitor with higher rights of audience for all civil proceedings. His specialism is civil procedure and a specific interest in catastrophic personal injury work. He also owns and runs a firm providing training and consultancy services in relation to personal injury, technology and practice development.

He has been the president of the Association of Personal Injury Lawyers on two occasions and is the current APIL secretary (elected in May 2022). He is also a Law Society council member and the chair of the Law Society Civil Justice Committee. He is a senior fellow of APIL and chair of the Senior Fellow Appointments Committee. He is involved in decisions in relation to interventions in civil proceedings recently including Belsner v Cam and Ho v Adelekun.

He has been a member of the Civil Procedure Rule Committee for six years.

Separately, he is a member of the advisory group to the Ministry of Justice on the Official Injuries Claims system and has assisted 3rd sector groups in preparing guidance documents to that system. He is currently working with the Civil Justice Council on its report on updating pre-action protocols and MOJ officials in relation to dispute resolution.

He is a member of the Lexis Nexis Consulting Editorial Board and is currently writing a guide to accidents at work. He is the case and digest editor for the Journal of Personal Injury Law produced by Thomsons Reuters. He is regularly consulted by the legal press in relation to personal injury matters and has spoken at Westminster Policy Forums, the ABI conference, the APIL conference and Law Society conferences, Radio 4, local radio and BBC News.

He has given evidence to Parliament on several occasions in relation to civil proceedings and is regularly consulted by civil servants and the senior judiciary as well.

John McQuater qualified as a solicitor in 1983 and is a director of Switalskis Solicitors Limited where he is joint head of personal injury and a member of the complex injury team.

He is a member of the Law Society Clinical Negligence Accreditation Scheme and a member of the Law Society Personal Injury Accreditation Scheme (as well as being an assessor for that scheme). He had, whilst the scheme was operation, catastrophic injury accreditation from the Law Society.

He is an APIL Accredited Clinical Negligence Specialist, an APIL Accredited Brain Injury Specialist and an APIL Accredited Fatal Accident Specialist (also being an assessor for each of those schemes). He is a solicitor advocate, with rights of audience in the Higher Courts for all civil proceedings.

He provides professional training on a range of subjects including procedure, practice management, occupiers' liability, contributory negligence, clinical negligence and evidence as well as regular updates on developments in the law. He has chaired sessions, and spoken, at many conferences including the APIL annual conference, the APIL clinical negligence conference, the APIL brain and spinal injury conference and the APIL business conference.
