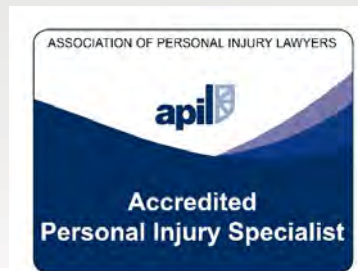


APIL ACCREDITATION



Am I eligible?

- **Firstly, you will need to be an APIL member, confirming that you work predominantly for claimants in the personal injury work that you do**
- **As an APIL member, you also agree to abide by the APIL code of conduct and consumer charter**
- **All practitioner and paralegal members of APIL are eligible for accreditation**
- **You don't have to wait until you can satisfy all the criteria for accreditation – you can complete sections of your application throughout your day-to-day work**



Why get accredited?

- **The APIL competence framework has been designed to be used as a development tool, in particular for appraisals**
- **It is geared around standards of occupational competence**
- **The standards can also be used for recruitment**
- **Members following the accreditation path are provided with excellent learning opportunities, developing skills and expertise along the way**



Why get accredited?

- **As members acquire expertise and experience, they work up the various levels**
- **When the Senior Litigator criteria has been satisfied, members are awarded with an individual quality mark/logo for use on their promotional materials and their profile will also be listed at www.apil.org.uk**
- **Those members with Senior Litigator status, or above, are promoted to injured people**



Why get accredited?

- Inclusion in the APIL online search by area of expertise, postcode/location, and level of accreditation
- Display of biographical details, CV and photograph
- Individual logo to use on your website profile and personal stationery
- Recognition by peers
- Supporting press and PR activity



Which level should I apply for?

There are two entry levels:

Litigator

Usually running cases under supervision, with less than five years' experience

Senior Litigator

Usually running cases unsupervised, with more than five years' experience



Which level should I apply for?

Plus for portal claims specialists

Portal Claims Handler

For members working on RTA, EL and PL claims through the MoJ portal and usually running cases under supervision



How do I apply?

Step one

Choose your level and download the portfolio document and guidance notes for your chosen level from the website:
www.apil.org.uk/individual-accreditation

Alternatively, contact the APIL office on
0115 943 5400 for assistance



Step two

Complete the candidate sections of the portfolio:

You need to provide 2 – 4 case names against each criterion

If you don't have a relevant case for one or more elements of the criteria, consult the guidance document for details of alternative evidence you can provide to your assessor

Step three

Appoint your assessor:

Refer to the 'Details of assessor' page in your portfolio for guidance on who would qualify to act as your assessor



Step four

Meet with your assessor so they can undertake your assessment and complete their sections of the portfolio.

If you don't have a relevant case for one or more elements of the criteria, your assessor should consult the guidance document for details of alternative evidence that will satisfy them that you meet the criteria.

Step five

Save or print a copy of the complete portfolio to retain in-house.



Finally . . .

**Click the 'Remove confidential information' button
on the last page to remove case names**

Print a copy for you and your assessor to sign

What happens next?

APIL will verify your application and contact you regarding the outcome

If successful, you can then:

- **Update your web profile with your specialist areas of work, biography and photograph**
- **Download your individual accredited logo, if you have gained Senior Litigator level or above.**



How do I keep my accreditation?

- **Accrue 16 hours of APIL accredited CPD training annually, and maintain your personal training log**
- **Revalidate your accreditation every five years***

***Revalidation doesn't require you to re-apply in full; it involves confirming compliance with a number of key points.**



How do I accrue APIL accredited CPD hours?

Attending courses accredited by APIL

- Attendance at APIL courses and conferences
- Attendance at APIL regional and special interest group meetings
- Attendance at in-house courses delivered by APIL in-house accredited offices, APIL or APIL trainers
- Attendance at APIL executive committee meetings
- Attendance at APIL accredited courses run by other training providers.

Other ways of accruing APIL hours

APIL accredited distance learning

Maximum 16 hours

Viewing APIL accredited personal injury programmes produced by APIL or other training providers

Writing for publications

Maximum 4 hours

Writing published personal injury articles for recognised law journals, books or podcasts

3,000 words 4 hours
2,000 words 2 hours

For Senior Litigators and higher:

Delivering personal injury training

Maximum 10.5 hours

Delivering training for APIL, other organisations or in-house in accordance with the APIL philosophy including podcasts

WRITING AND DELIVERING A PODCAST

1 hour per podcast
