After graduating in law he qualified as a solicitor in 1972 and spent over thirty years practising in Norfolk specialising principally in child care and mental health law.

He has a Post-graduate Diploma in Mental Health Law and a Masters Degree in Medical Law.

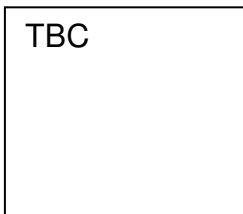
He has served as President of the Norfolk Law Society and Chair of the former Norwich and District Legal Services Committee.
