#### ***"Work-related stress"***



#### **By Dr Trevor Friedman, Medical Expert**

Dr Friedman qualified as a Medical Practitioner in 1982. He trained in psychiatry in Oxford and was subsequently Lecturer in Psychiatry at the University of Nottingham. He has been a Consultant Psychiatrist for Leicestershire since 1990.

Dr Friedman has held a number of positions within the Royal College of Psychiatrists. He is an assessor and supervisor for the General Medical Council. He is Chair of Comprehensive Research Network for Leicestershire, Northamptonshire and Rutland and Deputy Lead of the regional Mental Health Research Network. He has published over 60 research papers and other chapters in books and journals including research into child sexual abuse. He has been a member of Leicestershire Area Child Protection Committee and lead Consultant for Child Protection for my Trust.

Dr Friedman is involved in preparing medico legal reports across a wide range of areas on a regular basis. Dr Friedman has developed a particular interest in adults who experienced Child Sexual Abuse and have assessed approximately 800 people with such experiences and have given evidence on a number of occasions in such matters. He has assessed many cases for both claimants and defendants. He is a member of ACAL (Association of Child Abuse Lawyers). Dr Friedman first became involved in this area of practice as an expert in the Beck cases in Leicestershire. He has subsequently prepared reports in relation to abuse in North Wales, the North West of England, Devon and many other individual cases of child abuse both within institutions and other settings. Dr Friedman also assessed a large number of individuals for the Irish Redress Board of people abused whilst in institutions in Ireland.

Laura has a mixed civil practise, specialising in Personal Injury and Employment work. She is the Employment Team coordinator at 9 Gough Square.

In the employment field, Laura appears for claimants and respondents, both in the public and private sector. Her practice includes discrimination, unfair dismissal claims, whistle blowing, transfer of undertakings, workplace stress and bullying, commercial agency agreements, breach of contract and restraint of trade. In addition to representation in tribunals and courts, Laura is able to undertake advisory work on contracts, policies and workplace procedures.

Her Personal Injury practise is varied, encompassing everything from straightforward slips and trippers and road traffic accidents to work related upper limb disorders and industrial disease. She has a particular interest in the interface between Employment and Personal Injury Law, currently most relevant to stress, discrimination and health and safety at work.

Laura also has a developing Human Rights/Constitutional Law practice. She has appeared twice in the Privy Council on matters relating to the Mauritian education system and Constitution and continues to provide regular advice in this arena. As a Pegasus Scholar in 2001 Laura undertook work at the Human Rights Commission in Sydney, Australia.
