Speakers:

“Building the Quantum Evidence: The Role of the Occupational Therapist & Accommodation Experts”

By Jane Toplis, Specialist Architect, Bush & Company

Jane Toplis is a Registered Architect (ARB) and member of the Royal Institute of British Architects (RIBA), working as an Accommodation Expert for Bush & Company since 2007. She has acted as an expert on behalf of over 50 claimants and defendants.

Her advice has been sought on medical negligence claims, workplace injury claims and personal injury claims resulting from road traffic accidents. Jane Toplis has specialised in the field of accommodation for a wide range of claimants; including wheelchair users, amputees, claimants with profound learning and physical difficulties, claimants with vision impairments and a range of other permanent disabilities. Some of these claimants have been based outside the UK in France, Germany and the Netherlands. She has also acted as an expert on cases brought under the Disability Discrimination Act (now known as the Equality Act).

Jane is a Consultant Member of National Register of Access Consultants (NRAC) and has acted as a Specialist Access Assessor for the Arts Council, Heritage Lottery Fund and Civic Trust.

Anne Harris is an experienced Occupational Therapist, registered with the Health Professions Council and a member of the British Association of Occupational Therapists. She qualified in 1976, gaining a Diploma in Occupational Therapy from Dorset House, Oxford. Clinical experience in specialist neurology and spinal injury units provided the foundations for a career specialising in long term, complex disabilities.

On qualifying Anne Harris worked in a large NHS hospital. She planned and delivered rehabilitation programmes, assessed and organised provision of equipment for activities of daily living, social care and minor adaptations to housing prior to discharge and addressed re-integration into work.

She gained valuable experience of amputations and general surgery, cerebral vascular accidents and other neurological and medical conditions, orthopaedics, burns and plastics, geriatrics and rheumatology. Moving into Paediatrics she worked in a Child Development Centre, a special school and a residential unit for children and young adults with complex needs, including those with challenging behaviour, where she facilitated integration into family, school and community life.
