"Quantum issues in failure to remove cases"

I travel widely in the United Kingdom undertaking psychiatric assessments in various settings, including in the community, in prisons and in occupational health departments. I run once a month clinics in Huddersfield, West Yorkshire and also undertake regular assessments in Wales, the North West, the Midlands, East Anglia and throughout Devon and Cornwall. My day to day clinical activities involve the assessment and treatment of patients suffering from general psychiatric presentations including depression, anxiety and psychoses.

Since going into independent practice in 1992 I have had a particular interest in the assessment and treatment of victims of major disasters, terrorist events and personal injury cases in general.
