He is the author of academic articles relating to brain injury and the family experience of brain injury, and rehabilitation. He has authored a book and book chapters on the subject.

Mark has given evidence in the High Court and the Court of Protection, in criminal and Coroner's Courts as well as to the Houses of Lords and Commons.
