Preparing for trial can be daunting. One key part on such preparation, is the trial bundle.

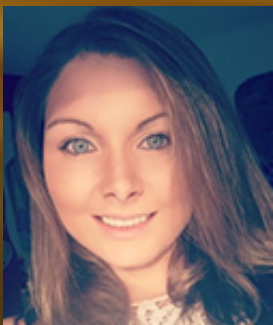
